Continuing Education on Workforce Development

On October 29th, Shipps, Glamann, and staff from several OWLS libraries attended a workshop presented by Kevin Virobik, Business Services Consultant for the Department of Workforce Development about the no-cost programs and services offered at the Menasha Job Center. Virobik shared a variety of resources to connect library customers to community experts in job search techniques, resume creation, interview preparation, and career exploration.

AAC Meeting

OWLSnet member libraries met in Appleton on November 2nd for our final AAC meeting of 2018. Key topics included a comparison of print management products and a review of subscription services and database trials for potential new shared resources.

County Budgets

On November 5th, the Outagamie County Board adopted the 2019 budget, without any changes to our request for library aids. The Waupaca County Board budget meeting is scheduled for November 13.

OWLS-Winnefox ILS merger exploration

The ILS merger exploration committee has not met since September. The next meeting will be November 28th and the topic will be governance and ownership of a combined consortium. This will be our first meeting with an outside facilitator. System staff will meet with facilitator, Michael Rust, on November 19th.

The PLSR Steering Committee met on November 7, 2018 to continue to review the draft recommendation report.
